# St. Croix County Fair Talent Show

## CONTEST RULES

1. All contestants must be amateurs, not professionals. The definition of professional is being a contestant who often is paid to entertain.
2. No talent act shall exceed the time limit of four minutes. Any talent exceeding the allotted time will be disqualified by the panel of judges
3. There will be two divisions – Vocal and Non-Vocal.  
Within the two divisions there will be four age categories:
  - 3<sup>rd</sup> Grade (completed) and under
  - 4<sup>th</sup> to 6<sup>th</sup> Grade (completed)
  - 7<sup>th</sup> to 9<sup>th</sup> Grade (completed)
  - 10<sup>th</sup> to 12<sup>th</sup> Grade
4. Equipment provided includes: sound system, microphones, and piano
5. First, second and third places will be awarded to each division and age group. First place will receive a cash prize of \$50; second place will receive \$25; and third place will receive \$10.
6. Final decisions on unanswered questions or problems will be decided by the St. Croix County Fair Talent Show Committee.
